## Dataset metadata

This dataset provides 2011 Census estimates that classify the out of term population in England and Wales aged 16 to 74 in employment the week before the census by industry. The estimates are as at census day, 27 March 2011. The out of term population is a redistribution of the usually resident population to their place of residence in out of term periods. Students who reported a second address that was a student's home address are counted at that second address. Students that did not provide an out of term address and usual residents who are not students are counted at their usual residence.

### Statistical Disclosure Control

In order to protect against disclosure of personal information from the 2011 Census, there has been swapping of records in the Census database between different geographic areas, and so some counts will be affected. In the main, the greatest effects will be at the lowest geographies, since the record swapping is targeted towards those households with unusual characteristics in small areas.

### Industry

The industry in which a person works relates to their main job, and is derived from information provided on the main

activity of their employer or business. This is used to assign responses to an industry code based on the Standard Industrial Classification 2007.
